In 2015, All Faiths Pantry (AFP) delivered over 465,000 total pounds of groceries to the households of between 480 and 1,800 low-income seniors and persons with mobility challenges every month. AFP receives donated services from volunteers who distribute food for it. AFP estimates its volunteer time at 4,555 hours in 2015, and values it at \$15 per hour, for a \$68,325 total. AFP succeeded in inspiring and coaching partnering community groups in initiating their own independent hunger relief programs and supported existing local anti-hunger programs.
